## Indication

YCANTH (cantharidin) is indicated for the topical treatment of molluscum contagiosum in patients 2 years old and older.

## IMPORTANT SAFETY INFORMATION

### What warnings should I know about YCANTH?

Do not get YCANTH in the mouth, nose, or eyes, and do not let YCANTH touch healthy skin. Life threatening or fatal toxicities can occur if YCANTH is taken by mouth. Avoid contact with areas of the body that have been treated, including contact by mouth. Damage to the eyes can occur if YCANTH comes in contact with the eyes. If YCANTH gets in the eyes, rinse eyes with water for at least 15 minutes.

# Help Clear Molluscum From Your Skin

You've just taken the first step in a process to help clear molluscum from your skin.

## What is YCANTH™?

YCANTH is a prescription medicine that is applied directly to molluscum bumps by a healthcare provider. It is the only treatment for molluscum approved by the US Food and Drug Administration.

It's important to know that in **clinical studies**, YCANTH was well **tolerated** and helped many patients completely clear their molluscum bumps in as little as 12 weeks.

- No serious side effects were reported in these studies

Local skin side effects at the application site may occur, including blistering, itching, pain, discoloration, and redness. Do not get YCANTH in the mouth, nose, or eyes, and do not let YCANTH touch healthy skin.



*Blistering is a sign that YCANTH is working to help clear molluscum from your skin.*

## Help Clear Molluscum From Your Skin (*cont'd*)

### What should I do after treatment with YCANTH™?

After treatment, follow your healthcare provider's instructions. You can return to your usual bathing routine *after* 24 hours or as otherwise recommended by your healthcare provider.



**Wash all treatment sites** 24 hours after treatment with a gentle soap and water. Avoid washcloths or abrasive surfaces. You may wash YCANTH off of your skin sooner if severe blistering or pain or other severe reactions occur.



**Avoid creams, lotions, oils, and sunscreen** on the treated skin. These products should not be applied for 24 hours or until after washing the affected and treated skin.



**If discomfort occurs**, over-the-counter medicine such as acetaminophen or ibuprofen can be taken as needed. Monitor the treated areas for excessive blistering, redness, pain, or itching.



**Blistering is a sign that YCANTH is working! Do not scratch or pick the blisters—let them heal on their own.**

## What should I expect in the coming days?

### *Immediately after treatment*

A small blister may develop on treated bumps. If you experience discomfort, you may use an over-the-counter medicine such as acetaminophen or ibuprofen.

- Do not cover treated areas with adhesive bandages. Avoid touching treated areas until after bathing

### *Within 24 hours of treatment*

Blisters usually form within 24 to 48 hours. Resume regular bathing and gently wash all treated areas after 24 hours.

### *The next few days*

Try to avoid squeezing, “popping,” or scratching any blisters, as they could become infected.

### *Seven to 14 days after treatment*

Blisters will heal on their own naturally. If scabs form at the treatment sites, try to avoid picking or scratching—removing the scab can increase the risk of scarring. Keep the areas clean and consult your healthcare provider for additional information.

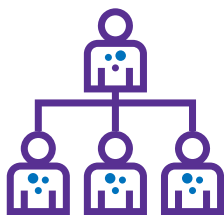
## What should I do next?

Make a follow-up appointment for your next treatment with YCANTH.

- Most people who took part in the clinical studies required more than one treatment to completely clear their bumps
- Molluscum remains highly contagious until all bumps are gone

## IMPORTANT SAFETY INFORMATION ABOUT YCANTH

### What warnings should I know about YCANTH?

- Do not get YCANTH in the mouth, nose, or eyes, and do not let YCANTH touch healthy skin. Life threatening or fatal toxicities can occur if YCANTH is taken by mouth. Avoid contact with areas of the body that have been treated, including contact by mouth. Damage to the eyes can occur if YCANTH comes in contact with the eyes. If YCANTH gets in the eyes, rinse eyes with water for at least 15 minutes.
- Local skin side effects at the application site may occur, including blistering, itching, pain, discoloration, and redness. Do not get YCANTH in the mouth, nose, or eyes, and do not let YCANTH touch healthy skin. If YCANTH contacts any unintended surface or healthy skin, immediately remove. If severe blistering, severe pain, or other severe skin side effects occur, wash off YCANTH immediately and contact your healthcare provider.
- YCANTH is flammable, even after drying. Do not expose YCANTH-treated areas to fire, flame, or smoke until YCANTH is washed off.
- Do not use YCANTH if you are allergic to any of the ingredients in YCANTH. The active ingredient in YCANTH is cantharidin. The inactive ingredients are acetone, camphor, castor oil,



denatonium benzoate, ethanol, gentian violet, hydroxypropyl cellulose, and nitrocellulose.

### **What are the possible side effects of YCANTH?**

The most common side effects are local skin side effects at the application site, including blistering, pain, itching, scabbing, redness, discoloration, dryness, swelling, and loss of the outer layer of skin at the application site. These local skin side effects are expected and are related to the anticipated blistering caused by YCANTH.

### **Do other medications interact with YCANTH?**

It is not currently known if any medications interact with YCANTH.

### **Can I use YCANTH if I'm pregnant?**

The potential risk of YCANTH for major birth defects, miscarriage, or maternal or fetal side effects is unknown. Given that YCANTH is applied to the outside of the mother's skin, use is not expected to result in exposure of YCANTH to unborn babies.

### **Can I use YCANTH if I'm breastfeeding?**

Do not use YCANTH on areas of the mother's body where YCANTH may come in contact with the breastfeeding child's mouth or eyes.

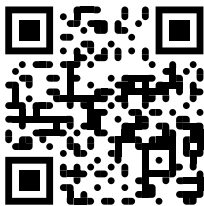
## IMPORTANT SAFETY INFORMATION ABOUT YCANTH

### What should I do if YCANTH is swallowed?

Taking cantharidin by mouth has resulted in kidney failure, blistering and severe damage to the stomach and intestines, excessive bleeding or clotting, seizures, and weakness or paralysis. Seek medical attention immediately if YCANTH is accidentally ingested.

These are not all the possible side effects of YCANTH.
